Rocky Mountain Photo Booth Terms & Conditions:

1. A deposit of \$200.00 is due at the time of booking to hold the date. The remaining balance of the event must be paid in full at a minimum 30 days prior to the event. Failure to provide full payment at that time may result in the rental agreement being voided by Rocky Mountain Photo Booth and all deposits paid will be forfeited by client.
2. All photos are the property of Rocky Mountain Photo Booth LLC but are freely downloadable for unrestricted use by the client and guests. Photos may be used in Rocky Mountain Photo Booth's website, advertising, etc. unless expressly prohibited in writing by the client.
3. For bookings made within 30 days of an event, the full balance of the contract is due at the time of booking and is completely non-refundable.
4. Client is responsible to ensure that adequate space and electrical hookups are provided by the venue for the photo booth. At a minimum, a 8 foot by 10 foot space with a nearby standard electrical outlet is needed for the placement of the photo booth. Additional space will be needed for a 6 foot table and 2 hat racks.
5. If the event is held outdoors, adequate protection for the photo booth from the elements must be provided. If adequate protection cannot be provided, Rocky Mountain Photo Booth reserves the right to terminate the contract on site without refund.
6. Rocky Mountain Photo Booth will provide an operational photo booth for the time contracted. If for any reason, a functional photo booth cannot be provided pursuant to this agreement, Rocky Mountain Photo Booth's maximum liability will be the refund of any payments received. If only partial service is able to be provided, the charges will be prorated accordingly.
7. The client agrees to indemnify and hold Rocky Mountain Photo Booth not liable and harmless against any and all damages, losses, claims for bodily injury and property damage occurring in, or arising out of Rocky Mountain Photo Booth's performance of this agreement.
8. Client agrees to be responsible for any damages done to equipment or property of Rocky Mountain Photo Booth by the client, his/ her guests, invitees, employees, independent contractors or other agents under the client's control.
9. Rocky Mountain Photo Booth reserves the right to refuse service to intoxicated or other unruly individuals who pose a danger to the company's equipment or staff.
10. The company needs approximately 90 minutes for setup prior to the event and a minimum of one hour post event to remove all equipment. Client will ensure that this is acceptable to the venue being used.
11. This agreement constitutes the entire agreement between Rocky Mountain Photo Booth and the client and supersedes all prior oral, written and other agreements between the parties. This agreement may only be amended in writing and signed by both the client and Rocky Mountain Photo Booth.
